1	ITT 36.4 - The invitation to tender is extended to Special groups (Youth, Women and PWD) - Does it mean that only Special Groups can participate in this tender?	The tender is NOT reserved/restricted for any Special groups but it is an open tender to all interested eligible bidders/tenderers.
2	Valid development and implementation authorization certificate (minimum of Gold or equivalent level) from the product developer/solution's copyright holder - Please let us know if we provide MAF from the developer, will it be accepted?	Manufacturer's Authorization Form (MAF) for development and implementation will be accepted.
3	Provide specifications of the required hardware environment -Hope we just need to provide only the specifications and not the pricing for the hardware, please confirm	The Agency has a serviceable Local Area Network (LAN) with various components; host devices (PC, laptops, tablets & smartphones), end devices (biometric readers), and intermediary devices (Firewall, Router, Switch, Wireless Access points). The LAN is connected to WAN via ISP. Any other hardware (servers or DBMS & ERP hosting platform etc) and software needed to implement the solution must be priced.
4	Supply, Installation, Implementation, Customization, Testing, Training and commissioning of a licensed ERP Software and related software utilities and add-ons. -Do you prefer any specific ERP systems like SAP, Microsoft, Oracle?	The Agency does not have a preferred ERP system.
